### Added important information

#### Geographic Driving Restrictions

At corporate and participating licensee locations vehicles can be driven throughout the Canadian provinces and the Continental U.S. with no restrictions. One-way rentals may be allowed based on vehicle availability.

The locations below have driving restriction exceptions to the above policy.

#### ALBERTA

Airdrie, Banff, Calgary, Canmore, Okotoks, Red Deer:

" Travel within Canada to other provinces is allowed with written permission from Budget office only. Check with the rental counter for details. Out of province travel may be subject to 10.00 CAD per day surcharge. Travel to the United States is only available within the state of Washington with written permission from the Budget office. Travel to, or within any other state is strictly prohibited. Customers driving within other states will be charged 0.50 CAD per km, for every km driven, during the entire rental. Check with the rental counter for details, as additional fees and restrictions may apply.

High Level, Rainbow Lake :

" Travel within Canada and the United States is allowed with written permission from the Budget office only. Check with the location for details.

#### BRITISH COLUMBIA

Campbell River, Cassidy, Castlegar, Comox, Courtenay, Cranbrook, Duncan, Kamloops, Kelowna, Nanaimo, Nelson, Parksville, Penticton, Port Alberni, Port Hardy, Prince George, Salmon Arm, Tofino, Vernon, West Kelowna:

" Allowed with written permission from Budget office only. Check with the rental counter for details. If the rate quoted has unlimited kilometers, they will be available for travel within British Columbia and Alberta only. If traveling outside of these areas the unlimited kilometers will not apply, instead kilometers will be charged at 200 free kilometers per day, 1400 free kilometers per week, 5000 free kilometers per month. Charge of .16 CAD per each additional kilometer over the free kilometers allowed. MAXIMUM 5000 kilometers allowed per rental agreement.

Richmond, Vancouver:

" Travel within Canada-

Travel outside of British Columbia is only allowed with permission from the Budget office. Rates with unlimited kilometers are only available for travel within British Columbia. If traveling in Alberta, rates with unlimited kilometers will have a 20.00 CAD per day surcharge. Travel to, or within any other province is strictly prohibited. Customers driving within other provinces will be charged 0.50 CAD per km, for every km driven, during the entire rental.

Note: 8 passenger and 15 passenger vans are only available for travel with British Columbia.

" Travel within United States-

Rates with unlimited kilometers are only available for travel within the state of Washington. If traveling within the states of Oregon or California rates with unlimited kilometers will have an additional charge of 20.00 CAD per day for the entire rental. Travel to, or within any other state is strictly prohibited. Customers traveling within other states will be charged 0.50 CAD per km, for every km driven during the entire rental. Travel to Alaska is not permitted.

" Mexico-

Travel into Mexico is not permitted.

Queen Charlotte, Sandspit:

" Vehicles are allowed on the island only. Vehicles are not permitted on the ferry.

Terrace:

" Travel within Canada and the United States is allowed with written permission from the Budget office only. Check with the location for details.

Victoria:

" Unlimited kilometers apply when driving in Victoria. If crossing a border (Canada or US) written permission must be obtained from the rental counter and there will be a mileage cap of 200 kms per day.

MANITOBA

Winnipeg:

" 15 passenger vans at this location are not allowed to travel within the United States.

NEWFOUNDLAND

Goose Bay:

" Travel within Canada's Atlantic Provinces: No restrictions. Unlimited KM rates are only valid for travel within the Atlantic Provinces (New Brunswick NB, Newfoundland NF, Nova Scotia NS and Prince Edward Island PE).

" For ANY travel outside of the following Atlantic Provinces (New Brunswick NB, Newfoundland NF, Nova Scotia NS and Prince Edward Island PE) and including travel to the United States: Restricted kilometer allowance and fees will apply. Customers must contact location or check upon arrival for details.

NORTHWEST TERRITORIES

Hay River, Yellowknife:

" Travel within Canada is allowed with written permission from the Budget office only. Check with the location for details. Travel into the United States is not allowed.

ONTARIO

Sarnia:

" Travel within Canada and the United States is allowed with written permission from the Budget office only. Check with the location for details.

Thunder Bay:

" Unlimited kilometer rates are not allowed if driving the vehicle outside of Ontario.

QUEBEC

Alma, Chicoutimi, Jonquiere, La Baie, Levis, Rouyn-Noranda, St Felicien, St Georges, Sept-Iles, Val D'Or:

" Travel within Canada and the United States is allowed with written permission from the Budget office only. Check with the location for details.

Drummondville, Plessisville, Sherbrooke, Thetford Mines, Trois Rivieres

Victoriaville:

" Vehicles can be driven throughout the Canadian provinces with no restrictions.

Vehicles are not allowed to travel into the U.S.

YUKON

Whitehorse

" Travel in Canada is only allowed to British Columbia, Northwest Territories and Alberta with permission from the Budget office. Travel is allowed into Alaska with permission of the Budget office. There is a 150.00 CAD per rental Cross Border Fee into the U.S. Travel is not allowed into the rest of the United States and Canada.

Dempster Highway Restricted Area Fee: 1500.00 CAD per rental.

### Additional driver information

Additional drivers must meet the same requirements as the renter. An additional driver

fee of 12.00 CAD per day will apply.

Additional Drivers must meet the same requirements as the primary driver

Fee CAD \$12.00 per day, per additional driver, up to a maximum CAD \$60.00 per additional driver, per rental agreement.

Fee waived for spouse and co-worker of a Budget Corp. account.

### Age information

At corporate and participating licensee locations in Canada, Budget will rent to customers between the ages of 21-24 with a valid credit card and driver's license. There is a 25.00 CAD per day underage surcharge for renters 21-24. Additionally, the following restrictions will also apply for renters between the ages of 21-24: Renters of luxury cars, mini-van, 12-passenger vans, specialty cars, standard SUV's, full size SUV's and premium SUV's will not be permitted.

In the Province of Quebec, the minimum age policy for all renters is 21 years with and under age fee of 25.00 CAD per day.

In the Province of Saskatchewan, the minimum age policy for all renters is 18 years and there is no underage fee.

Minimum age and underage surcharges can vary at licensee locations. It is best to check with the reservation team on the minimum age policy and restrictions at the location you are renting from if you are under 25.

Minimum age on groups H, L, P, V, X, Z is 25

Minimum age on all other groups 21

Under age fee of \$15 CAD per day (excluding Government/Corporate customers).

### Payment options

Budget accepts most major credit cards as credit identification at time of rental including:

" AirPlus

" Budget Charge Card

" American Express

" Diners Club International

" Discover

" JCB

" MasterCard

" Visa

At the time of rental, corporate locations will request an authorization on your charge card for the estimated rental charges plus 20 percent or a minimum of 750.00 CAD whichever is greater. At licensee locations, the hold amount may vary and will be determined based on rate, car group, length of rental and miscellaneous charges. While this hold is in place the funds will not be available for your use. When the rental is over, we will process the reversal but the bank may take time to post it back to the account. Some locations may not accept each of the referenced cards

#### Debit Cards

Debit cards are not accepted at the time of rental as credit identification. They can be used at time of return to pay for the rental.

### **Waiver and protection options**

Acceptance of Loss Damage Waiver reduces the renter and authorized additional driver's responsibility to 300.00 or 500.00 CAD for loss of, or damage to the Budget car, when they comply with the terms and conditions listed on the rental document jacket. At the time of rental the customer must initial whether he/she accepts or declines the LDW and optional services. LDW and optional services must be signed for at the rental counter. LDW is taxable.

If LDW is not accepted, the customer is financially responsible for the full value of:

- " Accident Damage
- " Glass Damage
- " Stolen items (radio, battery, etc.)
- " Vandalism
- " Theft of the car

#### **Canceling LDW**

Once LDW has been purchased it must remain on the contract. The customer has the option to return the car and close the rental agreement, however, this could change the rate for the rental agreement, and a different, possibly higher, rate could apply for a new rental.

" must sign a cancellation notice.

#### **Loss of Use**

The customer may also be responsible for reimbursing Budget for the revenue lost by not being able to use the car while it is being repaired or not recovered due to theft (referred to as Loss of Use).

#### **Exceptions**

Exceptions to the above policy are below:

#### **ALBERTA**

Airdrie, Banff, Calgary, Canmore, Okotoks, Red Deer, Springbrook:

" LDW is not available for drivers 21-24; they are responsible for the first 5000 CAD of damage. Drivers 25 and over are responsible for the full value of the vehicle if LDW is declined, 300 CAD or 550 CAD if accept.

#### **BRITISH COLUMBIA**

Abbotsford, Burnaby, North Vancouver, Richmond, Surrey, Vancouver:

" Purchase of LDW reduces the renter's responsibility to 1,000 for group Z PFAR Premium SUV and 500 for all other car groups.

Campbell River, Cassidy, Castlegar, Comox, Courtenay, Cranbrook, Duncan, Kamloops, Kelowna, Nanaimo, Nelson, Parksville, Penticton, Port Alberni, Port Hardy, Prince George, Salmon Arm, Tofino, Vernon, West Kelowna:

" Purchase of LDW reduces the renter's financial responsibility to Zero for all car groups except the following: Intermediate and Standard SUV (groups F and W) reduces liability to 1,000 CAD.

Queen Charlotte, Sandspit:

" Purchase of LDW reduces the renter's responsibility to 2500 CAD for all car groups.

Victoria:

" Purchase of LDW reduces the renter's responsibility to Zero for all car groups.

#### **NEWFOUNDLAND**

Goose Bay:

" Purchase of LDW reduces the renter's responsibility to 1,000 CAD for all car groups.

#### NORTHWEST TERRITORY

Hay River, Yellowknife:

" Purchase of LDW reduces the renter's responsibility to 3750 CAD for all car groups.

#### ONTARIO

Thunder Bay:

" Purchase of LDW reduces the renter's responsibility to zero or 500 CAD depending on car group rented.

#### QUEBEC

Drummondville, Plessisville, Sherbrooke, Thetford Mines, Trois Rivieres, Victoriaville:

" Purchase of LDW reduces the renter's responsibility to 750 CAD for all car groups.

Rouyn-Noranda, Val D'Or:

" Purchase of LDW reduces the renter's responsibility to 1500 CAD, 1750 CAD or 2000 CAD depending on car group rented.

Saint Georges:

" Purchase of LDW reduces the renter's responsibility to 500 CAD or 1000 CAD depending on car group rented.

#### YUKON TERRITORY

Whitehorse:

" Purchase of LDW will reduce the renter's responsibility to 2,500 to 5,000. CAD depending on the car group rented.

Damage to people and their property

Public Liability covers injury or death to a third party (persons outside the Budget vehicle). Property Damage covers damage to property other than the Budget vehicle and the renter's, driver's or passenger's property.

Depending on the location Budget will provide primary, secondary or no coverage up to the minimum limits required by law in that state. The Rental Document will state what type of coverage is provided.

Personal Accident and Effects Insurance (PAE)

PAE provides the renter and occupants of the Budget car with accidental death benefits and coverage for certain medical reasons. Renters are protected both in and out of the rental vehicle throughout the entire rental period; occupants are covered only while in the Budget vehicle. In addition, PAE provides protection against loss of or damage to certain personal property of the renter and individuals traveling with the renter.

PAE Benefits

Type of Coverage

Accidental Death - Renter 100,000 CAD and Passengers 10,000 CAD.

Medical Coverage for Injuries - Renter or Passengers 3,500 CAD.

Ambulance Service - Renter or Passengers 250 CAD.

Personal Property Benefits - The maximum coverage per individual is 600 per claim with a maximum coverage of 1,800 CAD for all individuals combined. A deductible of 25.00 CAD per person will apply.

Some types of personal effects are not covered under this policy check with rental location or reservations for exceptions.

Customer responsible for full value of vehicle if LDW is declined. If purchased customer is responsible for CAD \$300 for car groups A,B,C,D,E and CAD \$500 for ALL other car groups.

### **Drivers license and ID requirements**

All named drivers must hold a full and valid drivers licence. All drivers must have at least 2 years driving experience.

Car group P requires a Class 4b Drivers Licence.

International renters require a drivers licence in English or French or an International Licence.

Group T:: class 4B driver's license required.

International renters require driver's license in English or French or International Driver's license

### FastBreak

Fastbreak services available.

Look for customer name on monitor and proceed to designated vehicle area. Choose vehicle and proceed to exit booth. Present drivers license and hand tag to Budget agent. To book input membership number in the ID field.

### Fuel charges

The vehicle is rented with a full tank of gas and must be returned with a full tank of gas or there will be a charge for refueling. If you have refueled please keep your receipt for verification purposes.

Most locations offer a prepaid gas option to purchase a full tank at market value which allows the customer to return the vehicle without a full tank of gas. There is no refund for unused gas.

If the vehicle is driven less than 125 kilometers there may be an additional refueling fee, unless a gas receipt is presented at time of return. The customer can check at the time of rental for complete details.

### Miscellaneous information

#### e-Tolls

Please be aware of roads that may be "cashless tolls" and drivers on these roads are not able to pay cash once they have entered these roads. Renters can automatically opt into our e-Toll service program and will be charged 17.00 CAD plus GST/HST per rental, plus incurred tolls at the maximum prevailing rates posted by the toll authority. The charges may take 4-8 weeks after the rental to be billed to your credit card/debit card on file.

#### Extended Roadside

Extended Roadside offers fast, dependable rescue service for our renters for a daily charge. It is offered to our customers at time of rental and provides roadside assistance for lost keys and remote entry device lockouts, flat tire service, towing (if the vehicle is inoperable), jump starts and emergency fuel delivery (up to 3 gallons).

The cost of replacing a key for most vehicles is at least 100 CAD. Locksmith charges range by area. In addition to the cost of keys, there is a tow charge or delivery fee that can range from 50 to 250 CAD depending on the distance. By accepting the Extended Roadside Service, you won't have to worry about incurring additional expense for the listed items while on the road.

### Returns

If you want to extend the rental or wish to return the vehicle to a different location please contact us as soon as possible. At the latest, this should be before the end date and time on your rental agreement. You will be advised whether the change is possible and any additional costs when you call.

If you fail to extend your rental you will be charged the prevailing pay at location prices for the extra days as well as a late return administration fee of 10.00 CAD for each day or part of a day until the vehicle is returned.

If you return the vehicle to a different location then you agreed to at time of rental your rate could default to a different rate available on the day you return the vehicle and a one way fee will be applied.

CSS Child Safety Seat - 20-40 lbs or 9.07 - 18.16 kilos

CIS Infant Child Safety Seat - 2-20 lbs or 2.27 - 9.07 kilos

CBS Child Booster Seat - 40-80 lbs or 18.16 - 36.32 kilos

\*Other requirements may apply for different locations, example: rear-facing seats and booster seats

GPS

GPS features a touch-screen 3D map to help you arrive at your destinations safely.

Turn-by-turn, point-to-point directions are available in more than 40 languages so you can keep your hands on the wheel and attention on the road.

Winter Tires

Winter Tires are mandatory on certain roads or the renter/driver may be ticketed by RCMP.

Quebec-

It is mandatory that all vehicles registered in the province of Quebec be equipped with winter tires during the winter months of December to March. All rentals will be charged a daily Tire Management Fee for year-round tire maintenance. The fee is subject to concession recovery fees, GST and QST.

All Other Provinces-

Winter tire equipped vehicles maybe available in the winter season for reservations at some locations. Additional fees vary by location and car group.

Snow Tires are mandatory for all vehicles licensed within the Province of Quebec. Tire Management Fees may vary by location, car group and rental date. Customer must check at time of rental for applicable fee.
