Drivers license and ID requirements

Each driver must show photographic proof of identity or their passport at the start of the rental. All drivers must present a full and valid driving licence which has been held for at least 1 year. The licence must be valid for use in the renting country.

The reserved vehicle will be delivered to you, checking your credit limits (credibility, credit score) in our offices. In prepaid reservations, if your credit limit is not deemed appropriate, the vehicle rental fee will be returned to you in 7-14 days. Credit limit checks will be performed in our offices, giving you information.

International customers must show their passport at the beginning of their rental. Otherwise due to Turkish regulation and police restrictions car wouldnt be provided. If your licence is in non-roman alphabet you must provide an International Driving

Licence.

Turkish citizens who will rent a vehicle with a driver's license issued in a foreign country acknowledge and undertake that they are able to drive in Turkey only depending on the terms and conditions stated below:

- 1) Starting from the date of entrance to Turkey, a vehicle can be driven for maximum 1 year with a driver's license issued in a foreign country.
- 2) Those who have been in Turkey for more than six months must keep with them a Turkish translation of their driver's license certified from a foreign diplomatic representation or a notary public at all times while driving, along with the license itself.
- 3) To be able to drive in Turkey after one year of residency, the driver's license issued abroad must be substituted with a Turkish driver's license. As for foreigners who will rent a vehicle in Turkey, they acknowledge and undertake the terms and conditions below to be able to drive in Turkey with their driver's license issued abroad:

- 1) Starting from the date of entrance to Turkey, a vehicle can be driven for maximum 6 months with a driver's license issued in a foreign country.
 - 2) To be able to drive in Turkey after six months of residency, the driver's license issued abroad must be substituted with a Turkish driver's license.
- The substitution of foreign driver's licenses with a Turkish driver's license is subjected to the below-mentioned procedures and principles, without prejudice to any relevant law in effect and to bilateral and multilateral agreement provisions:

- a) Application may be made to any traffic registry institution
- b) Information and documents to be presented during application are determined by the General Directorate of Security.
- c) For those who will issue a driver's license, the conditions stated in Law No. 2918 Art. 41 and pertaining to non-convictedness, age, education and health are exactly required, except for the training and test condition.
- d) If deemed necessary, an investigation may be carried out on the authenticity of the driver's license via the Turkish Ministry for Foreign Affairs and Turkish representations abroad.

For A, B, F, H, M car groups 1 year valid drivers license is required, for D, G, N, O, I, J car groups 2 year valid drivers license is required, for L, E, K, P car groups 3 year valid drivers license is required.

Each driver must show photographic proof of identity or their passport at the start of the rental. All drivers must present a full and valid driving licence which has been held for at least 1 year. The licence must be valid for use in the renting country.

International customers must show their passport at the beginning of their rental.

Otherwise due to Turkish regulation and police restrictions car wouldnt be provided. If your licence is in non-roman alphabet you must provide an International Driving Licence.

For A, B, C, F, H, P car groups 1 year valid drivers license is required, for D, G, M, N, O car groups 2 year valid drivers license is required, for I, L, E, K, J car groups 3 year valid drivers license is required.
