Taking your vehicle outside the country

The vehicle can be taken cross border, free of charge, only with a written permission issued by Avis, to the following countries; Belgium, France, Germany, Italy, Andorra, Denmark, Finland, Ireland, Luxembourg, Norway, Portugal, Austria, Spain (with the exception of Ceuta), The United Kingdom, Sweden or Switzerland.

Please note this is cross border only, the vehicle must return to the Netherlands.

The vehicle is equipped in accordance to the Dutch law, when taking the vehicle outside the Netherlands, the renter must ensure that the vehicle meets the legal requirements of the concerning country.
